- Enrolled Agent is a Federally Authorized Tax Practitioner Entitled by the U.S.A. Department of the Treasury.
- An Enrolled Agent is a Person Who has Earned the Privilege of Representing Taxpayers Before the Internal Revenue Service by Either Passing a Three-Part Comprehensive IRS Test Covering Individual and Business Tax Returns, or Through Experience as a Former IRS Employee.

### EA Exam Pattern

The Enrolled Agent Exam Consists of **3 Parts** and Each Part has **100 Multiple Choice Questions** Which must be Completed within **3.5 Hours**.

15 Questions Out of 100 MCQs will be Experimental and Out of the Rest 85 MCQs, at least 70 must be **CORRECT** to **PASS** EACH Paper of the Special Enrollment Exam (SEE) from the Internal Revenue Service (IRS)

Candidates are Notified of their Scores **Immediately** Upon Completion of the Computerized Exam.
